Curriculum Policy 2017

Aims

- **A.** To program, deliver, monitor and review a balanced and integrated educational program, based on the General Capabilities and learning areas of the Western Australian Curriculum.
- **B.** Transition to full implementation of the Australian curriculum by 2018.
- C. To comply with the requirements of the School Curriculum and Standards Authorities Western Australian Curriculum and Assessment outline and the School Curriculum and Standards Authority Act 1997.
- **D.** To comply with the Education and Care Services National Regulations 2011.

Principles

- **A.** Staff meetings are held to develop and refine timetables each term and for whole year planning.
- **B.** Whole school programs are developed by the teaching staff in conjunction with the Principal.
- **C.** Curriculum is implemented by individual teachers, with support from the Principal and the staff as a group. Progress in the implementation of the Australian Curriculum will be monitored and discussed, with plans made for professional development for staff.
- **D.** Teachers program for the learning areas defined in the Western Australian Curriculum and Assessment outline.
- **E.** Specialist teachers may be contracted to address specific learning areas.

Responsibilities

- **A.** Council is responsible for overseeing the implementation of the curriculum mandated by SCSA.
- **B.** The Principal is responsible for the overall implementation of the Curriculum, accountability to the School Curriculum and Standards Authority, coordinating the development of whole school programs, supporting teachers in providing an educational program, and ensuring all learning areas are addressed within the school week and over the school year.
- C. Teachers are responsible for the educational program of their class, contributing to whole school program development and implementation, continuing to develop practices supporting

the implementation of the Curriculum Framework and Australian Curriculum, and contributing to the formation of a timetable which includes all learning areas.
